The Tariff setting process consists of three steps: The allowed revenues (including the remuneration method for TSO/DSO costs) and other relevant costs are determined.



The Unit Transmission Tariff is calculated by adding the charges applied to the generation (G) and load (L), which includes infrastructure costs, the costs of purchasing system services and losses.



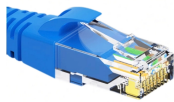
