CCC Certification Costs for Low Voltage Complete Equipment: The costs for CCC certification of low voltage complete equipment include application fees, registration fees, testing fees, and factory inspection fees. Prior to this date companies could undertake self-declaration however this is no longer possible, and companies must obtain China Compulsory. The Detailed-Rules for Low-voltage electrical components (hereinafter referred to as the Detailed-Rules) are compiled, in accordance with the requirements of the "Implementation Rules for Compulsory Product Certification Low-voltage apparatus Low-voltage components" (CNCA-C03-02. Voluntary product certifications provide an indication to distributors and/or the end user in China that a certified product meets Chinese quality standards and.

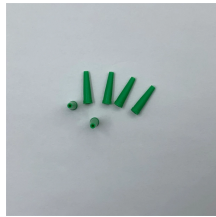
