

## How to apply quotas for Ic optical modules



### Overview

Quotas are established by legislation, Presidential Proclamations or Executive Orders. AB 701 creates 13 new sections of the Labor Code regulating the use of quotas by “Warehouse Distributions Centers,” which are defined in Labor Code section 2100 by referring to North American Industry Classification System (NAICS) codes. These include General Warehousing and Storage, Durable Goods. What is the role of CBP in administering import quotas?
